

# Sighthound Terms of Use

Welcome to our web site, www.sighthound.com (the "Website"), a site owned and operated by Sighthound, Inc ("Sighthound"). Sighthound provides our products, materials, and services to you through our Website subject to the following terms and conditions (the "Terms of Use"). The Terms of Use applies to any person (collectively "you" or "your") who accesses this Website, views the contents of this Website, submits videos or other content, and/or accesses, downloads or otherwise uses our products or services (defined below).
